# I MINUTES AND EXECUTIVE REPORTS

- A. Secretary's Report/Minutes. The minutes for the August meeting were emailed. The minutes were accepted.
- B. Treasurer's Report: Melita Aquino not present. Carole reported that we received a check from National for \$1931 as reimbursement for an AED + First Aid kit purchased in 2020.
- C. Membership Report: Tracy Silva not present. No Report
- 1. Sanctions: Carole Langenbach reported we had 151 sanctioned events in 2022, and already have 14 for 2023
- D. Vice President's Report: Carol Coram. Carol will follow up to confirm names of the Athlete reps to the board. Also noted there is a push by National to include Para Athlete representative(s) on Association boards.

## E. President's Report: Ken Emerick.

- 1. Expressed thanks for everyone who has supported the recent XC meets.
- F. Office Manager's Report: Carole Langenbach. There will be a PNTF BOD post annual USATF convention + Christmas Social on Dec 11th, details to follow. Kenny noted that trip reports be should emailed out, and only items of particular interest be brought up informally for in-person discussion if/as needed.

#### II OLD BUSINESS

- A. USATF Annual meeting in Orlando FL: Patti Petesch will lead our PNTF Association delegation, a smaller group representing us than in prior years & they will prioritize which side sessions to attend. Our delagates are: Patti, Kenny Emerick, Ed Viering, Carol Coram, Katie Burnett, Sue Hoppe, Paula Everdell, Holly Genest, Martha Mendenhall, and Johnnie Williams. Patti noted this will be a more expensive trip due to the location & made a motion to increase the attendance stipend from \$300 to \$500 for this year. Motion passed. National now requires Athlete representatives receive the same stipend as the other delagates, and it was noted our by-laws should be updated to reflect that.
  *Paula Everdell: Paula will be inducted into the Officials Hall of Fame. Congratulations Paula!*
- B. WIAA coaches basic rules summary charts: Bob Springer presented chart decks developed for each category of T&F events that will be used for briefing coaches @ the WIAA meeting on Jan 21. Secretary to see if they can be posted on our website for future reference.
- C. Officials Pay for USATF sponsered events; Discussion around what practices are employed by other associations (if any), payment mechanics, the need to report to IRS as income (or not) & how that would work, including possibly hiring & paying an outside entity to deal with the administration of checks/payments/taxes. Some question if reporting to the IRS is even required if "pay" is only a reimbursement stipend for expenses (e.g., gas money, petty cash) supporting a volunteer activity for a non-profit organization. Open, Masters, and Youth committees need to provide input regarding the mechanics & amounts, as any stipends for officials would come out of those budgets & could impact event fees. Some details to sort out & will keep as an agenda item for further consideration.

- A. The At-Large members for the new term were emailed & announced. Carol Coram (V.P.) will confirm our Athlete reps and notify the Secretary, who will send out to distribution once available. *Special thanks to Ed Viering for his 12 years of service as the PNTF Secretary. Ed will continue on the Board as one of the At-Large reps.*
- B. Web site maintenance. Per Dave Skelton's assessment & memo, our Association web site is current & meets accreditation requirements except for the updating of our new BOD membership. Secretary will forward updated PNTF BOD membership information (names, email addresses) to Andy Martin to update. No other updates were proposed.
